Breeding fee fresh/cooled semen €950,- (€850,- if payed before January 1, 2025)

Early booking fee €700,-

Multiple mare fee €800,- (€700,- if payed before January 1, 2025)

1. Fees and expenses

- a. Charges: a bookingfee of €500,- is due with a signed contract. Balance of the stud fee €950,- is due before shipment of the fresh/cooled semen. Upon payment in full, the semen can be ordered by the mare owner. The breeding fee is exclusive the costs of the collection of the semen and costs for shipment. Breeding fee can be fullfilled in the following bankaccount: NL79INGB0007383402 on the name of Mag's Showhorses BIC code: INGBNL2A Bank: ING Bank
- b. Investment In Art has a multiple mare discount. On a second breeding, the mare owner gets a discount on the original breeding fee of €150,-.
- c. Investment In Art has an early booking discount of €150,- on the original breeding fee of €950,- when this contract is signed before December 31, 2024 and a booking fee of €500,- is payed as well. Balance of the stud fee is due before shipping of the semen.

2. Breeding station

Investment In Art is standing on stud at K&L Stables in Kwadijk, The Netherlands.

The mare owner has to order semen one day before shipment untill 18:00 o'clock by the stallion owner, Anick Worp.

Semen can only be shipped when the breeding fee is payed in full.

3. Mare registration

- a. A copy of the mare registration papers, with current owner listed or lease agreement must accompany this contract. The owner recorded on the registration certificate will be recorded on the stallion breeding rapport.
- b. The mare owner gives notice to stallion owner when the mare is in foal.

4. Live foal guarentee

The mare is quarenteed on 'live foal'. The term 'live foal' means that the foal resulting from the breeding shall stand and nurse within twenty-four (24) hours. If a live foal does not result from the breeding, the mare owner will be entitled to rebreed the mare the following season only, to the stallion for no additional stud fee. Proper notification shall be defined as written certification by a licensed veterinarian that the mare has slipped or produces a non-viable foal. When the mare comes to die, no stud fee will be refunded. However, an other mare may be used for the breeding of this contract, only in consulation with the stallion owner.

5. Shipping terms and conditions

The mare owner is responsible for all the costs of the shipment of the semen. For questions or to order semen, the mare owner must contact Anick Worp by telephone. Phonenumber: +31 612434869
